A. The meeting was called to order by Vilma at 12:02PM.

B. Summary of Old Business taken at the meeting:

Discussion of deadline for Summary of Data and Use of Results for academic programs (tabled from last meeting)

- Lisa opened the floor for the committee to decide on a deadline for Academic Programs who need data from the final exams and projects. Several deadlines were suggested, but ultimately there was agreement to pose the question to the respective department heads to make the decision.
- Motion from Adam that PROAC will contact academic department chairs directly for a date that is suitable for the submission of the final two areas of the PAF (Summary of Data and Use of Results).

Discussion: Program Review Report (PRR) Tentative Deadline, August 9th

- Motion passed unanimously.

C. Summary of New Business taken at the meeting:

Discussion of programs on Checklist

- Geri opened the floor for a decision on action for the 4 programs who scored zeroes on the first three parts. Should they move forward with the remaining 2 parts of the PAF?

- Team leads (who scored the PAFs of these 4 programs) agreed and stated that they should not go forward. They also pointed out the need for further training & support in writing outcomes and aligning the measures to the outcomes and collecting data. It was confirmed that this support would be given by OIE to help these 4 programs succeed in program assessment.
- Motion by Adam to accept the recommendation: HR, UCEDD, OAR, and the Library will not proceed to data collection and the use of results (due their score of zero on the first part of program assessment).
- Seconded by Wil.
- Motion passed unanimously.
- There is a possibility of one more program (PLA) that may not proceed with the last 2 areas. Geri is waiting to hear from the team lead.
